IV. DOC 2025-27 Biennial Plan Proposal.....Jessica Beach, YCDCJ Director

- DCJ Director Jessica Beach presented the Biennial Plan Budget (see power point).

V. Round Table (as time allows).....

- Brandon Dross has a question for Juvenile Probation for a constituent regarding MIP process and assessments, Jessica Beach to follow up with Brandon and the Juvenile Department.
- Lindsay Manfrin announced the Opioid Pain Addiction Recovery Summit will be happening October 14<sup>th</sup>. Also, on October 2<sup>nd</sup> and 3<sup>rd</sup> will be a Suicide Prevention Training and Planning. First day is the training and second day is specific to community leaders.
- Commissioner King talked about his interest in starting a Public Recovery High School. An example model just opened in Marion County. There could also be consideration of a satellite campus in Yamhill County.
- Sheriff Sam Elliott gave a shout-out to Chief Wood, McMinnville Police and Community Justice regarding the coordinated efforts to apprehend an individual that was a safety concern in the community earlier this week. Due to this local collaboration, this Adult on Supervision was apprehended safely. He thought the membership would have interest in this as public safety is the mission of the LPSCC. Jessica Beach added a huge thanks to Chief Wood and his team, Sarah Vogel and the DA's Office for the professionalism and collaboration that allowed this situation to go smoothly and safely. Commissioner King added a thank you to the local teams.
- Fay Shuler reminded us that October is Domestic Violence Awareness Month. The Henderson Houses' Crown of Yamhill County Fundraiser is scheduled for October 4<sup>th</sup>. Henderson House is also bringing back the old school DV rally in Newberg on October 9<sup>th</sup>.
- Sheriff Elliott reminded everyone that, due to the passage of House Bill 3643, October 9<sup>th</sup> is also the first annual Oregon Youth Suicide Day and there will be a sunrise event planned at the Discovery Meadows Park.
- Jessica Beach added that our CJC JRP Formula and Competitive Grants have been officially awarded. However, the CJC Treatment Court Grants are on hold until the next CJC Commissioner meeting on 10/21/25 due to four appeals that have been filed about grant awards. As a result, funding on the ARC, CCS and JRC grants are on hold until the CJC Commissioners can review and finalize the previous vote of approval for Treatment Court grant approvals.
