This Seventh Amendment to Oregon Health Authority 2013-2015 Intergovernmental Agreement for the Financing of Community Addictions and Mental Health Services dated as of July 1, 2013(as amended, the "Agreement"), is entered into, as of the date of the last signature hereto, by and between the State of Oregon acting by and through its Oregon Health Authority ("OHA") and Yamhill County ("County").

WHEREAS, OHA and County wish to modify the Financial Assistance Award set forth in Exhibit D-1 of the Agreement.

2. Capitalized words and phrases used but not defined herein shall have the meanings ascribed thereto in the Agreement.

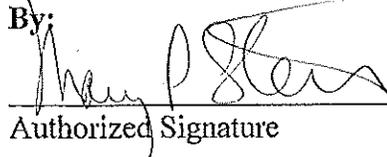
