**AGREEMENT FOR SERVICES**  
**Resource Connections of Oregon, Inc.**  
**(Fiscal Intermediary Services for DD Program)**

THIS AMENDMENT #1 TO FISCAL INTERMEDIARY SERVICES FOR DEVELOPMENTAL DISABILITIES PROGRAM (this "Amendment #1), is made and entered into by and between Yamhill County, a political subdivision of the State of Oregon, hereinafter referred to as "County", acting by and through the Developmental Disabilities Program of its Health and Human Services Department, and Resource Connections of Oregon, Inc., an Oregon nonprofit corporation, 3876 Beverly Avenue NE, Suite G-1, Salem, OR, 97305, Federal ID. Number 93-1280907 hereinafter referred to as "Contractor".

**RECITALS:**

A. County and Contractor are parties to that certain agreement dated as of August 1, 2013 (the "Underlying Agreement"), pursuant to which Contractor acts as intermediary to pay family support and in-home comprehensive service care providers for its clients who are developmentally disabled.

B. County and Contractor now desire to amend the Underlying Agreement upon the terms and conditions as more particularly set forth herein below.

C. Capitalized terms not defined herein shall have the meanings attributed to such terms in the Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein below and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties hereto, County and Contractor, intending legally to be bound, hereby agree as follows:

1. Exhibit A-1, RCO fee schedule 2013-2014 is hereby deleted and replaced with the attached RCO Fee Schedule 2014-2015 Option #2 effective February 1, 2014.

2. Ratification. Except as otherwise expressly modified by the terms of this Amendment #1, the Underlying Agreement shall remain unchanged and continue in full force and effect. All terms, covenants and conditions of the Underlying Agreement not expressly modified herein are hereby confirmed and ratified and remain in full force and effect, and constitute valid and binding obligations of County and Contractor enforceable according to the terms thereof.

3. Authority. County and Contractor and each of the persons executing this Amendment #1 on behalf of County and Contractor hereby covenants and warrants that: (i) such party has full right and authority to enter into this Amendment #1 and has taken all action required to authorize such party (and each person executing this Amendment #1 on behalf of such party) to enter into this Amendment #1, and (ii) the person signing on behalf of such party is authorized to do so on behalf of such entity.

4. Binding Effect. All of the covenants contained in this Amendment #1 shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, legal representatives and permitted successors and assigns.

5. Counterparts. This Amendment #1 may be executed in multiple counterparts, each of which shall be an original, but all of which shall constitute one and the same Amendment #1.

6. Recitals. The foregoing recitals are intended to be a material part of this Amendment #1 and are incorporated herein by this reference.

**RCO Fee Schedule 2014-2015**

**fee for service: fiscal services for families and individuals**

**Option #2**

Payroll will be processed in 1 main run, for payment on or around the 10<sup>th</sup> of the month. There will be a second run for payment on or around the 20<sup>th</sup> of the month.

	Frequency	Fee
Support Plans with 1 provider (generally under \$300/mo)	Monthly	\$44.50 / month
Support Plans with 2 or more providers (generally under \$300/mo)	Monthly	\$75.50 / month
Support Plans over \$300 with only 1 provider	Monthly	\$75.50 / month
Comprehensive In-Home Support with plans up to \$3,000/month and up to 4 providers	Monthly	\$75.50 / month
Comprehensive In-Home Support with plans over \$3,000/month (or with more than 4 providers)	Monthly	\$93.50 / month
Comprehensive In-Home Support with plans over \$3,000/month and multiple vendor payments	Monthly	\$101.00 / month
One-time only payments to a Vendor	1 Time Only	\$12.50 / check

**\*\* It is not a standard practice of RCO to offer monthly draws. For those few customers needing payroll draws, checks to insurance companies, and tracking of 24-hour shift schedules, the rate may be negotiated to reflect the additional services.**
