RE: Unilateral Modification of Juvenile Crime Prevention Basic Services and Diversion Intergovernmental Agreement (Agreement Number: 12672b)
Purpose: Funding Increase

Dear Commissioner George:

This letter serves as notice that the Oregon Youth Authority is modifying funding to Yamhill County under the referenced intergovernmental agreement.

Exhibit B, Section 11 of the above captioned agreement between the State of Oregon acting by and through its Oregon Youth Authority ("OYA") and Yamhill County ("County") dated July 1, 2013 (as amended from time to time the "Agreement") states, in relevant part, that "If the Oregon Legislative Assembly, Legislative Emergency Board or Oregon Department of Administrative Services increases or decreases the amount of money appropriated or allotted for implementation of the Services under this Agreement, OYA may, by written notice to County, unilaterally increase or decrease the amount of the funding in this Agreement, in proportion to the increase or decrease in the appropriation or allotment, provided that OYA increases or decreases, in the same proportion, the funds awarded to all other counties under similar agreements."

The OYA is hereby notifying the County that the Agreement is modified by replacing the current Exhibit E of the Agreement with the attached new Exhibit E. Except as so modified, all other terms and conditions of the Agreement remain in full force and effect.
