Laura,
As you know there has been a carryover line in the maintenance budget for the purchase of a van. Two weeks ago I asked Russ Heath to look around and see what he could find for us. The criteria I gave was I want a new to fairly new ¾ ton service van with a ladder rack and the separation between the drivers compartment and cargo area. Russ found right away a van that meets what we want at Chuck Calvin Ford here in town.
A New van is running at approximately \$28,800 we have \$30,000 budgeted. However the van Russ found is a 2012 with approximately 40,000 miles and it has the accessories we would like for it to have. They were asking \$21,995 and Russ was able to get them to agree to \$18,995 Russ has already taken the van to our shop and had our mechanics thoroughly through it. Russ stated that it passed all their criteria for purchase.
Russ sent out a request to Jim Doran for quotes from their lots and they failed to respond. Newberg Ford only has a ½ ton so they too declined to offer a quote. Russ then looked to the Portland area for comparable quotes and found nothing under the \$20,000 range.
If possible I would like to request that this issue be considered by the board to authorize the purchase of the van from Chuck Calvin Ford.
Please advise if there is more I need to do in making this request.
