**AMENDMENT TO  
SPECIALTY COURTS GRANT PROGRAM**

This is Amendment Number 3 to Contract # GF-13-009 ("Agreement") between the State of Oregon, by and through the Criminal Justice Commission ("CJC"), and Yamhill County Health and Human Services Department. ("Grantee")

I. The Agreement is hereby amended as follows (except as provided otherwise, new language is indicated in bold and by underlining; deleted language is italicized and bracketed):

**A. Section 3 is amended as follows:**

**3. Project Cost; Grant Funds.** In accordance with the terms and conditions of this Agreement, CJC shall provide Grantee an amount not to exceed [~~\$90,338~~] **\$198,743** in Grant Funds for eligible costs described in Section 6 hereof.

**B. Exhibit A is amended as follows:**

- a. The Project End Date, June 30, 2014, is deleted and is replaced with June 30, 2015.
- b. The title of the "Budget Summary" is amended to read "Year 1 Budget Summary."
- c. The Year 2 Budget Summary is added as follows:
