### AMENDMENT # 1

The Professional Services Agreement between MID-VALLEY BEHAVIORAL CARE NETWORK and YAMHILL COUNTY, executed in August 2014, is amended by agreement of the parties in the following respects:

1. This Amendment is effective retroactively for the period of September 1, 2014, through June 30, 2015.
2. Section 3 in the main body of the Agreement is modified as follows:
  - a. The maximum amount allowable for staff and administration/overhead under the Agreement is increased by \$60,018.25 from \$52,763 to \$112,781.25. The maximum amount allowable for reimbursement of rental assistance and/or move-in expenses under the Agreement is increased by \$70,000 from \$84,000 to \$154,000.
3. Section 2 in Attachment A: Statement of Work (Rental Assistance and Supported Housing Services) is modified as follows:
  - a. The number of "slots" allocated to CONTRACTOR is increased by 10 (ten) from 5 (five) to 15 (fifteen).
4. Section 4(b) in Attachment A is modified as follows:
  - a. The Full-Time Equivalent (FTE) that CONTRACTOR shall assign to serve as a residential support specialist is increased by 0.33 FTE from 0.25 FTE to 0.58 FTE. The FTE that CONTRACTOR shall assign to serve as a peer support specialist is increased by 0.33 FTE from 0.25 FTE to 0.58 FTE.
5. The following is added to the disbursement table in Section 4(b)(i) in Attachment A:

September 1, 2014, through June 30, 2015	\$55,217	\$4,801.25	Upon execution of this Amendment

6. All other provisions of the original Agreement remain unchanged and in effect.
