The attached Service Element Prior Authorizations (SEPA) contain funding allocation adjustments to our Intergovernmental Agreement #134297/142149 with the Department of Human Services for our Developmental Disabilities program. SEPA 3626223 removes \$2,873.31 in funding and allocates \$19,851.96 to Case Management instead of Local Administration for the 2013-2014 fiscal year.
