Hi Mary and Laura,

Attached is a quote for installation and monthly service fee for internet connection at our Booth Bend leased Health and Human Services location. OnlineNW controls the dark fiber cable connection that runs underground at Booth Bend so we have only requested a single quote for this service. Travis Ward has been working with us on this project and this is the preferred method for establishing our internet connection at the site. If approved, the contract will run month-to-month with a \$449.95 monthly fee and a one time installation charge of \$5,000. The expense is budgeted under our facilities operating expenses in the fiscal year 2015-2016 Adopted budget.

I recommend the Board authorize me to sign the Agreement upon receipt in order to expedite the installation. Please let me know if you have any questions.
