Dear Commissioners,  
Several residents in Yamhill County are gathering signatures for letters to send to the ODOT Bridge Committee, asking that Palmer Creek Bridge be rehabilitated during the 2018-21 round of Federal bridge funding. In an effort to present a unified appeal, Public Works will also write a letter urging the repair of Palmer Creek Bridge (the Bridge Committee confirmed it would not consider replacement). It is my understanding the committee will meet sometime in August to decide which bridge projects to fund.
