Hi Mary and Laura,

The attached Service Element Prior Authorizations (SEPA) increase the funding allocations to our 2015-2017 Intergovernmental Agreement with the Department of Human Services for our Developmental Disabilities program for Comprehensive In-Home Support Services for Adults and In-Home Support for Children programs. These funds are client designated and paid directly to the providers for services delivered to clients enrolled in the programs. A small amount of these funds may be passed through to the County for purchases of items to assist the client or in care of the client and is included in our 2016-2017 Health and Human Services Adopted Budget.

Claims for the Comprehensive In-Home Support Services for Adults were paid for an average of 57 individuals per month and 71 unique individuals year-to-date (July 1, 2015 through June 16, 2016) and an average of 50 individuals per month and 69 unique individuals year-to-date for the In-Home Support for Children program.

I recommend the Board approve these SEPA as written. Please let me know if you have any questions.
