

Good afternoon,

This last winter the city upgraded the sewer main that runs down Evans Street, in doing so they discovered that the sewer lateral that comes from the Spence House is made of clay which is no longer acceptable. The city has since issued us a letter stating that they are requiring us to upgrade this line.

I called around to some local excavating companies and was able to get two of them to come out and look at the job, they were Kizer Excavating and Jerry Rainwater Excavating. Kizer was the only one to provide a quote to perform the work. Their quote is \$9,850.00 to excavate and replace the line, remove all waste, perform any asphalt repairs, and the cost of permits.
