WHEREAS, the owner of property identified as 22021 NW Kutch Road, Yamhill Oregon 97148, Tax Lot 3507-1501, has petitioned the District board to annex his property into the District; and

WHEREAS, the District board, on May 10, 2016, agreed to the annexation of the subject property into the District; and

WHEREAS, pursuant to ORS 198.857, the Board has scheduled and held a public hearing, and has considered the local comprehensive plan for the area and other relevant information provided to the Board; NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY AS FOLLOWS:

Section 1. The Board of Commissioners hereby approves the annexation of the Yamhill Fire Protection District property identified as 22021 NW Kutch Road, Yamhill Oregon 97148, Tax Lot 3507-1501, at the request of the property owner. The property is shown on the map attached as Exhibit A to this resolution, and incorporated herein by this reference.


