

## Amendment # 3

WHEREAS, Lane County, hereinafter referred to as COUNTY, a political subdivision of the State of Oregon, and YAMHILL COUNTY, hereinafter referred to as CONTRACTOR, have agreed that it is in the mutual interest of both parties to amend the Contract dated August 01, 2008 for CONTRACTOR'S On-line foodhandlers training/testing IGA project.

The purpose of this change is to terminate by mutual consent, to replace with a new Agreement.

Now, therefore, the parties agree that the Contract should be amended as follows:


- 1 The Agreement is terminated by mutual consent, effective December 31, 2016
