IN THE BOARD OF COMMISSIONERS OF THE STATE OF OREGON

FOR THE COUNTY OF YAMHILL

SITTING FOR THE TRANSACTION OF COUNTY BUSINESS

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in formal session on October 19, 2017, at 10:00 a.m. in Room 32 of the courthouse, Commissioners Mary Starrett and Richard L. "Rick" Olson being present. Commissioner Stan Primozych being excused.

Also present were Laura Tschabold, County Administrator; Ken Huffer, Deputy County Administrator; Christian Boenisch, County Counsel; Silas Halloran-Steiner, Health & Human Services Director; Nicole Montesano, News-Register; Dave Adams, KLYC Radio and others as listed on the sign-in sheet.

Commissioner Starrett called the meeting to order at 10:00 a.m.

A. **PUBLIC COMMENT:** This thirty-minute time period is reserved for public comment on any topic other than a quasi-judicial land use matter or other topic scheduled for public hearing. Unless extended or restricted by the Chair or majority of the Board, public comment will be limited to three minutes per person.

David Wall stated concerns regarding public safety in the rural areas and referred to the handout that he provided each Commissioner commented on the information he had given out previously. We need more deputies for rural areas.

Angel Mendoza invited the Commissioners to attend the upcoming, first ever Veterans and First Responders Parade that will take place on November 11th.

Tom Konkolewski, Timothy Debolt, Tammy Story, Patricia Seemueller and James Craver offered comments to the Commissioners in regards to the YCEA union contract negotiations currently still on going. Mr. Craver announced that the union had filed a notice of intent to strike with the Employment Relations Board as of today.

The meeting was recessed for the Great Oregon Shakeout earthquake drill at 10:19 a.m.

The meeting reconvened at 10:31 a.m.

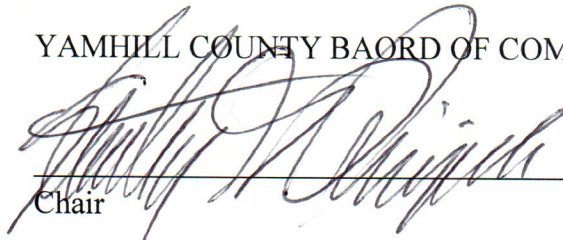

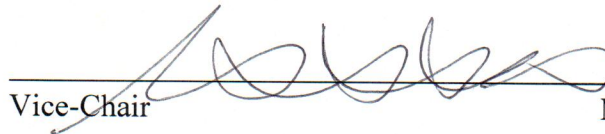
