1. Community Justice Dept. update – Jessica Beach

Ms. Beach reported that she has completed one year as the division head of Community Justice. She reports an Adult Probation Officer recruitment will open soon. She noted the week of July 17th will be Parole and Probation officer appreciation week.

Ms. Beach reports that she is working on the 4th quarterly report on Justice Reinvestment, which will be presented to LPSCC by July 25th. She also noted that recruitment for Hatfield Scholarship position through PSU is in motion which offers a 9 month position that assists with data in pretrial. Ms. Beach responded to questions by the Board regarding justice reinvestment (recidivism).
