Note 1:

All Yamhill County Commissioners take part in any or all of the various Associated Oregon Counties (AOC) steering committees that meet monthly to review issues of interest to counties and to make policy and legislative recommendations to the AOC Legislative Committee and the AOC Board of Directors. Membership on all steering committees is self-selected with Yamhill County Commissioners serving on several steering committees. The steering committees include **Governance, Health & Human Services, Legislative, Natural Resources' Public Safety, Transportation & Community Development, and Veterans.**

The AOC president, with approval of the Board of Directors, may appoint County Commissioners to other standing committees and task forces as necessary and desirable. The committee is a standing or ADHOC group created to address issues involving a particular subject on an ongoing basis as issues arise, a task force is a group created to address particular issues within a limited period of time. Currently there are task forces and committees to address Budget, Audit, and Dues.

Note 2:

As members of the Associated Oregon Counties, all Yamhill County Commissioners are automatically members of the National Association of Counties (NACO). As NACO members Commissions can apply and are elected or appointed to various NACO ADHOC task forces and committees such as **Large Urban County Caucus (LUCC), Rural Action Caucus (RAC), Arts and Culture Commission, Healthy Counties Advisory Board, Immigration Reform Task Force, International Economic, Development Task Force, Resilient Counties Advisory Board, and Veterans and Military Services Committee.**

Yamhill County Commissioners may apply and be appointed to various policy steering committees **including Agriculture and Rural Affairs, Community, Economic and Workforce Development, Environment, Energy and Land Use, Finance, Pensions and Intergovernmental Affairs, Health Human Services and Education, Justice and Public Safety, Public Lands, Telecommunications and Technology, and Transportation**
