

**SECOND AMENDMENT TO AGREEMENT
SCHOOL BASED HEALTH CENTER SERVICES
Yamhill County HHS and YC SBHC**

THIS SECOND AMENDMENT TO AGREEMENT ("Amendment #2") is made by and between Yamhill County, a political subdivision of the State of Oregon, acting by and through its Department of Health and Human Services ("County"), and YC SBHC ("YC SBHC"), an Oregon nonprofit corporation, 120 N Larch Place, Yamhill, OR 97148

RECITALS:

A. County and YC SBHC are parties to that certain agreement dated as of August 11, 2016 (the "Underlying Agreement"), memorialized as B.O. 16-329, pursuant to which YC SBHC now operates the Yamhill Carlton School Based Health Center. The Underlying Agreement was assigned from Alana Bailey, FNP, and assumed by YC SBHC on September 20, 2016, memorialized as B.O. 16-384. The Underlying Agreement was first amended July 21, 2017, ("First Amendment").

B. County and YC SBHC now desire to further amend the Underlying Agreement upon the terms and conditions as more particularly set forth herein below.

C. Capitalized terms not defined herein shall have the meanings attributed to such terms in the Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein below and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties hereto, County and YC SBHC, intending legally to be bound, hereby agree as follows:

1. Section 5 of the Underlying Agreement is amended to include the following: "One time funding in the amount of \$14,400 is added to support SBHC operations, purchase clinic supplies, implement youth-friendly clinic upgrades, and provide professional development and training for SBHC staff." The balance of Section 5 remains unchanged.

2. The balance of the Underlying Agreement remains unchanged.

3. Ratification. Except as otherwise expressly modified by the terms of this Amendment #2, the Underlying Agreement shall remain unchanged and continue in full force and effect. All terms, covenants and conditions of the Underlying Agreement not expressly modified herein are hereby confirmed and ratified and remain in full force and effect, and constitute valid and binding obligations of County and YC SBHC enforceable according to the terms thereof.

4. Authority. County and YC SBHC and each of the persons executing this Amendment #2 on behalf of County and YC SBHC hereby covenants and warrants that: (i) such party has full right and authority to enter into this Amendment #2 and has taken all action required to authorize such party (and each person executing this Amendment #2 on behalf of

such party) to enter into this Amendment #2, and (ii) the person signing on behalf of such party is authorized to do so on behalf of such entity.

5. Binding Effect. All of the covenants contained in this Amendment #2 shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, legal representatives and permitted successors and assigns.

6. Counterparts. This Amendment #2 may be executed in multiple counterparts, each of which shall be an original, but all of which shall constitute one and the same Amendment #2.

7. Recitals. The foregoing recitals are intended to be a material part of this Amendment #2 and are incorporated herein by this reference.
