Below is an addendum to the regular payment section outlined below.

Regular Payment

We will bill a flat fee of \$25,000 on July 25, 2019 after the petition for review is filed. If the petition for review is granted, we will bill a flat fee of \$25,000 on the 25th of each month following the filing of the opening brief and the reply brief, and after oral argument is held, totaling \$100,000.

We will send an itemized statement to each of you for fees and expenses, which is due and payable on receipt. Linn County is responsible for 50%, Douglas County is responsible for 25% and Yamhill County is responsible for 25% of the total fees and expenses incurred each month. 
