SCOPE

Replacement of 48 cameras within the YCJDF, integration into host BVMS Platform

INCLUSIONS

EXCLUSIONS

- All preexisting cabling to be utilized shall be intact and serviceable, any and all cabling that will not perform to TIA standards shall be repaired/replaced on a time and materials basis once identified.
- All areas are to be accessible by DND staff during the peripheral device replacement phase of the project, (it is understood that YCJDF Staff will be escorting DND personnel).
- High Power, PoE, Gig Network switches shall be provided and installed by YCIS Staff prior to the commencement of work.
- All IP Addresses shall be provided by YCIS Staff, in writing, Prior to the commencement of work.

TERMS AND CONDITIONS

B.O.20-238

ALL work will be completed to conform or exceed National Electrical Code requirements. Additionally, work will be performed in compliance with the U.S. Department of Labor Occupational Safety and Health Standards as interpreted and enforced by local authorities, and, to the DND Security and Communications Quality in Performance criteria for electrical installations.

In addition bid is based upon ALL work being performed within a 40-hour work week, during normal business hours. No overtime is included.

All material is guaranteed to be as specified. All work to be completed in a workmanlike manner according to standard practices. Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders, and will become an extra charge over and above the estimate. All agreements are contingent upon strikes, accidents or delays beyond our control. Owner is to carry, fire, tornado, and other necessary insurance. Our workers are fully covered by Workmen's Compensation Insurance.

DND Security and Communications will bill for all work completed through the last day of each calendar month and Owner agrees to pay by the 25th of the following month. Finance charge of 2% per month (24% per annum) on all past due accounts not paid by the 25th of the month. All remaining balances are due and payable upon notification of completion and final acceptance of the installation by local inspection authorities.
