THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (“the Board”) sat for the transaction of county business in combined informal/formal session on Thursday, July 30, 2020 at 10:00 a.m., Room 32 of the Yamhill County Courthouse, Commissioners Casey Kulla, Mary Starrett and Richard L “Rick” Olson being present.

**WHEREAS**, on March 17, 2020 the Yamhill County Board of Commissioners (“Board”) formally declared a State of Emergency within Yamhill County to address the continued spread of COVID-19, memorialized as Board Order 20-93 and Resolution 20-03-17-1 (the “Declaration”); and

**WHEREAS**, on March 26, 2020 the Board formally extended the Declaration through June 30, 2020, unless extended or earlier terminated by the Board, memorialized as Board Order 20-105 and Resolution 20-03-26-1; and

**WHEREAS**, on June 25, 2020 the Board formally extended the Declaration again through July 31, 2020, unless extended or earlier terminated by the Board, memorialized as Board Order 20-205 and Resolution 20-06-25-2; and

**WHEREAS**, the spread of COVID-19 continues to affect all of Yamhill County and the Board has determined that continued measures in the form of a further extension of the Declaration is needed;
