Hi Ken,

I would like to add the request below on to this week's agenda. We just received the formal notice of this opportunity yesterday and need to respond by Friday, October 23, 2020.

I am requesting permission to opt-in for \$24,624 in additional funding available from the Oregon Health Authority, Oregon Immunization Program for COVID-19 vaccine planning and infrastructure support. While this amount is not specifically included in our Health and Human Services 2020-2021 Adopted Budget, we have sufficient budget authority to receive the funds if awarded.

This funding can be combined with the \$23,302 CARES Influenza Prevention Project funds approved under BO 20-336 & 20-353. As you may recall, the funds are intended to:

- Provide enhancement to the prevention of influenza disease in the time of COVID
- Protect the healthcare system from preventable influenza, with a primary focus on communities most affected by COVID-19 disease
- Prepare all stakeholders for the arrival and implementation of activities related to COVID-19 vaccine
- Improve the local, regional and state immunization infrastructure

Suggested Board Agenda language: "Authorize Lindsey Manfrin or designee on behalf of Yamhill County Health and Human Services to submit an application for funding from the Oregon Health Authority in the amount of \$24,624."
