

AMENDMENT No. 6 TO YAMHILL COUNTY JAIL - FOOD SERVICES

THIS AMENDMENT NO. 6 is entered into this 1st day of April, 2021 by and between the **Yamhill County**, a political subdivision of the State of Oregon, acting by and through the Sheriff's Office ("County"), and **Aramark Correctional Services, LLC**, a Delaware limited liability company, having its principal place of business located at 2400 Market Street, Philadelphia, Pennsylvania 19103 ("Aramark").

WITNESSETH:

WHEREAS, the County and Aramark did on July 9, 2011, enter into an Agreement for the management of the food service operation at the Yamhill County Jail and the Yamhill County Juvenile Detention Center (as amended, the "Agreement");

WHEREAS, the Yamhill County Jail houses adult offenders and the Yamhill County Juvenile Detention Center houses juvenile offenders;

WHEREAS, the parties acknowledge the need to address the volatility in the cost of food commodities; and

WHEREAS, the parties desire to amend the Agreement as hereinafter set forth, effective as of July 1, 2020.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as set forth below. Capitalized terms used but not defined in this Amendment have the meanings ascribed to such terms in the Agreement.

- 1. Price:** In accordance with Paragraph 6 of the Agreement, the parties mutually agree that the price per meal charged to the County by Aramark from July 1, 2020 through June 30, 2021, shall be as set forth on Attachment A. The parties agree that pursuant to paragraph 6 of the Agreement that the price shall increase July 1, 2021 as a result of changes in the Consumer Price Index by an amount mutually agreed to; not to exceed 3.5%. At the time of the increase, the Agreement shall be amended to reflect the new pricing.
- 2. Effect of Amendment:** Except as hereinabove provided, said Agreement is hereby in all other respects ratified and confirmed.
