SITTING FOR THE TRANSACTION OF COUNTY BUSINESS

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in combined session on September 22, 2022, at 10:00 a.m. in a virtual meeting via Zoom, Commissioners Lindsay Berschauer, Casey Kulla and Mary Starrett being present.

Also present were Ken Huffer, County Administrator; Christian Boenisch, County Counsel; Jodi Gollehon, County Counsel II; Mark Lago, Public Works Director; Shane Hoffman, Information Technology Manager; and Megan Marasco, BOC Staff. Ken Friday, Planning Director; Colton Totland, Assistant County Counsel and Nohely Barajas-Montalvo, Legal Assistant participated via Zoom.

Jodi Gollehon noted a correction in the exhibits prior to approval; she summarized the board order and said approval will approve the property list, authorize advertisement and the return of sale process. After discussion, Commissioner Starrett moved approval of item I2. The motion passed, Commissioners Berschauer, Kulla and Starrett voting aye.

3. **B.O. 22-305** - Consideration of approval to accept a quote and purchase from Structured for Nutanix server/storage infrastructure and support for the 2022-23 fiscal year in the amount of \$146,840.
