Hi Mary and Ken,

I would like permission to apply for grant funding from the Oregon Health Authority for the Early Assessment and Support Alliance (EASA) block grant for \$6,050. While these funds are not included in Health and Human Services 2022-2023 Adopted Budget, we have sufficient budget authority.

The EASA program provides information and support to young people experiencing symptoms of psychosis for the first time.

If approved and awarded, the funds are to help cover the cost of accessing additional services and supports not provided by YCHHS. This includes obtaining specialty evaluations like Neuropsychiatric assessments, access to health and wellness activities that may have admission costs or membership fees, and other resources to meet basic needs (food, shelter, clothing, transportation).
