IN THE BOARD OF COMMISSIONERS OF THE STATE OF OREGON

FOR THE COUNTY OF YAMHILL

SITTING FOR THE TRANSACTION OF COUNTY BUSINESS

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY (“the Board”) sat for the transaction of county business in combined session on December 7, 2023, at 10:00 a.m. in Room 32 of the Yamhill County courthouse, and in a virtual meeting via Zoom, Commissioners Kit Johnston and Mary Starrett being present. Commissioner Lindsay Berschauer was absent.

Also present were Ken Huffer, County Administrator; Christian Boenisch, County Counsel; Jodi Gollehon, Assistant County Council II; Mark Lago, Public Works Manager; Ashley Watkins, Solid Waste & Recycling Coordinator; and Jason Foose, County Surveyor. Nohely Barajas-Montalvo, Legal Assistant participated via Zoom.

The Commissioners reviewed the joint schedule for the week of December 11 – 17, 2023. No other county business was discussed.

D. PUBLIC COMMENT: This time period is reserved for public comment on any topic other than: 1) agenda items, 2) A quasi-judicial land use matter, or 3) a topic scheduled for public hearing. The Chair may limit the length of individual comments.

Barend Van Zanten gave public comment regarding property tax exemptions for widows of military personnel.

G. CONSENT AGENDA:

Commissioner Starrett moved approval of the consent agenda. The motion passed, Commissioners Johnston and Starrett voting aye. Commissioner Berschauer was absent for the vote.

Contracts & Grants

1. **B.O. 23-439** - Approval of Amendment #2 to Agreement #168-20 (previously #143-20) between Yamhill County Solid Waste Department and the Department of Environmental Quality (DEQ) (B.O. 20-246) extending the contract through December 31, 2024, for continued work to be completed at the old Newberg Landfill.

2. **B.O. 23-440** - Approval of the placement of a stop sign at Morgan Lane intersection with Booth Bend Road.

3. **B.O. 23-441** - Approval of a revised fee schedule for the Office of Assessment and Taxation, effective January 1, 2024.

H. OLD BUSINESS: None.

I. OTHER BUSINESS (Add-ons and non-consent items):

1. Consideration of approval to select vendor Model-1 as the vendor to purchase five vans, three mini-vans and two nine-passenger vans according to Yamhill County Transit, Yamhill County, and Oregon Department of Transportation (ODOT) Procurement standards.

The consensus of the Board was to move agenda item I1 to December 14, 2023, for further discussion. There was no action taken.

J. PUBLIC HEARINGS:

1. Docket #RV-7-2021: A public hearing to consider a proposed road vacation and deed dedication for an adjusted roadway.

Commissioner Johnston opened the public hearing at 10:21 a.m. There was no public testimony received in support or opposition of the proposed road vacation. County Surveyor Jason Foose commented the action was in the best interest to the public motivated by the owners desire to make the description record match with the physical road alignment. The public hearing was closed at 10:23 a.m.

a. **B.O. 23-442** - Consideration of a Board Order approving a Road Vacation and accepting a deed dedication for an adjusted roadway; Docket No. RV-7-2021.

Commissioner Starrett moved approval of item J1a. The motion passed, Commissioners Johnston and Starrett voting aye. Commissioner Berschauer was absent for the vote.

2. Docket #RV-1-2023: A public hearing to consider a proposed road vacation.

Shawn Keinonen, whose property borders the proposed road vacation, said his understanding was that there were no plans to develop the road and vacating it would not affect his or neighboring access. Mr. Keinonen was in support of the road vacation.

County Surveyor Jason Foose submitted testimony by the landowners, Kim and John Stanley, in opposition of the road vacation, stating that they did not want to lose their road access which Mr. Foose assured vacating the road would not sever access. There was no additional public testimony received in opposition of the proposed vacation.

a. **B.O. 23-443** - Consideration of a Board Order approving a Road Vacation; Docket No. RV-1-2023.

Commissioner Starrett moved approval of item J2a. The motion passed, Commissioners Johnston and Starrett voting aye. Commissioner Berschauer was absent for the vote.


