THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY (“the Board”) sat for the transaction of county business in combined session on January 4, 2024, at 10:00 a.m. in Room 32 of the Yamhill County courthouse, and in a virtual meeting via Zoom, Commissioners Lindsay Berschauer, and Mary Starrett being present. Commissioner Kit Johnston participated via Zoom.

Also present were Ken Huffer, County Administrator; and Christian Boenisch, County Counsel. Nohely Barajas-Montalvo, Legal Assistant participated via Zoom.
