RE: FY2024 SHSP Grant Applications

For the grant year FY2024, Yamhill County Emergency Management has received the following grant application requests:

Competitive Grant Applications

Yamhill County Emergency Management - \$ \$75,000.00

Yamhill County is seeking a grant for \$75,000.00 for the addition of a mobile command center/EOC to Yamhill County's response capabilities. A Mobile Command Center/EOC would allow for an efficient, coordinated response to better handle emergencies, such as those caused by natural disaster or violent extremism (terrorism).

City of Newberg - \$1,000,000.00

Water Treatment Plant Basin Covers – The project will address the vulnerability of the Newberg Water supply to terrorist sabotage or contamination of its open-air water basins.

McMinnville Water and Light - \$100,000.00

McMinnville Water & Light is seeking a grant for \$100,000 and will contribute (match) \$50,000 for the installation of a camera security system, alarm sensors (doors and reservoir hatches) and lighting improvements. The project will include installation of security cameras, alarm sensors on all doors and hatches of the reservoirs and pump station (access points to reservoirs and pump station), and lighting upgrades to increase visibility and improve security.
