

AMENDMENT No. 3 TO YAMHILL COUNTY AGREEMENT FOR TELEPHONIC CRISIS SUPPORT SERVICES LINES FOR LIFE

Contract No. (BO 17-251)

THIS AMENDMENT is made and entered into this 27 day of June, 2024, by and between the YAMHILL COUNTY, a political subdivision of the State of Oregon, acting by and through its Health and Human Services Department (“County”), and Lines for Life of 5100 SE Macadam Avenue, Suite 400, Portland, Or 97239 (“Contractor”) (collectively, the “Parties”).

WHEREAS, The Parties executed a services contract on December 21, 2016, pursuant to Board Order No. 16-518 for Telephonic Crisis Support services (the “Contract”); and

WHEREAS, The Parties previously amended the Contract on June 29, 2017, pursuant to Board Order No. 17-251 (Amendment #1) to add YouthLine Peer-to-Peer Crisis Line support and Outreach services; and

WHEREAS, The Parties previously amended the Contract on May 13, 2021, pursuant to Board Order No. 21-177 (Amendment #2) to remove DBT Coaching services; and

WHEREAS, The Parties now wish to amend the Contract to remove YouthLine Peer-to-Peer Crisis Line support and Outreach services; and now, therefore

THE PARTIES hereby agree to amend the Contract as follows (new language is indicated by underlined font and deleted language is indicated by strike-out font):

1. The section entitled “Contractor’s Services” as amended in Amendment #1 is amended to read as follows:

Section 2 of the Underlying Agreement is hereby amended to ~~include~~ remove the Services as detailed in the YouthLine Peer-to-Peer Crisis Line Support and Outreach Program YouthLine Crisis Line Support and Referral which is attached ~~hereto~~ to Amendment #1 as Exhibit A. ~~and which is incorporated herein by this reference.~~

2. The section entitled “Payment” as amended in Amendment #1 is amended to read as follows:

“Effective July 1, 2024, County shall reimburse Contractor per the following fee schedule for performing the Services detailed in Section 2 of this Agreement, until this Agreement is terminated as provided in Section 7 or further amended in a written document executed by both parties. County agrees to make payment within thirty days of receipt and approval of billing documents.

“County shall reimburse Contractor ~~\$50,000~~ \$0 per year (~~\$4,166.67~~ \$0 per month), beginning July 1, 2017-2024, ~~through June 30, 2019~~ for the additional YouthLine Peer-to-Peer Crisis Line Support and Outreach Program Services detailed in Exhibit A to ~~this~~ Amendment #1.”

Except as expressly amended above, all other terms and conditions of the original contract are still in full force and effect. The Contractor certifies that the representations, warranties, and certifications contained in the original contract are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
