WHEREAS, Lane County, hereinafter referred to as COUNTY, a political subdivision of the State of Oregon, and YAMHILL COUNTY, hereinafter referred to as AGENCY, have agreed that it is in the mutual interest of both parties to amend the Intergovernmental Agreement dated January 01, 2020 for AGENCY'S Shared Use Agreement - Foodhandlers project.

The purpose of this change is to extend the Agreement and provide funding for the period of the extension.


Now, therefore, the parties agree that the Intergovernmental Agreement should be amended as follows:
