Adopt-a-Road Volunteer Information

The Yamhill County Adopt-A-Road program provides an opportunity for volunteers to clean up litter along Yamhill County Roads.

Volunteers:

- May be individuals, families, groups, or businesses.
- Must be willing to commit to at least one year of volunteer service, with a minimum of four litter clean-ups per year.
- Must be 16 years-of-age or older, with at least one adult supervisor present at all times that work is being done.
- May have to walk in uneven terrain, lift and carry filled bags, and work safely around stressful situations, such as heavy traffic and high noise levels.
- Must provide their own transportation to/from the project site and set their own schedule.
- Will be required to sign a Liability Waiver & Release prior to volunteering.

Upon request, Yamhill County Public Works will provide volunteers with trash bags, reflective vests, and grabbers. Once litter is collected and secured in the provided trash bags, it is the volunteer's responsibility to call Yamhill County Public Works and notify them of the location where the bags need to be picked up.
