Application for Suppressed Owner Status in Assessment & Taxation Records

For our office to suppress the name of the owner of a property, **the owner must complete this form, identify all properties/tax lots for which ownership information must be suppressed, and submit documentation of the reason for their request.** Documentation may include proof of employment status, a restraining order or other protective order, or documentation from the Attorney General's Office.

When an owner's name is suppressed, other persons, entities, and agencies, including emergency services, will not have access to the owner's name through the Assessor's Office's records. It may also render the US Postal Service unable to deliver your tax statements or other required notices. It is your responsibility to provide any necessary documents or information to other persons, entities, and agencies that may have previously used the County's records to send notices of proceedings. It is also your responsibility to pay your taxes on time regardless of whether you receive a statement. If you wish to receive your statements electronically, please contact our office.

While our office will make every effort to protect your property records, we cannot guarantee that no unauthorized person will ever be able to access your records. Additionally, we may be required to disclose information about you to other authorized government agencies in the conduct of their lawful business. Be aware that other records agencies (courts, county records, health agencies, etc.) might hold records that could be used to locate you. We urge you to contact these agencies and determine if they offer a similar program.
