Mental Health Services

CRISIS SERVICES

Yamhill County HHS provides urgent mental health services for adults and youth 24 hours a day, seven days a week.

Services include:

- Telephone support and referrals
- Crisis screening and assessment
- Crisis intervention
- Linkage to psychiatric hospitalization or crisis respite services
- Pre-commitment investigation
- Hospital liaison services

If you are experiencing a crisis, please call our crisis hotline at 1-844-842-8200. You can also contact the National Suicide & Crisis Lifeline by dialing or texting 988. Both services are available 24 hours a day, 7 days a week.

Crisis Respite

Crisis respite services provide short-term, voluntary supports to help a person stabilize, resolve problems, and connect with additional supports after experiencing a mental health-related crisis. Respite services are a community-based alternative to psychiatric hospitalization, or as a step-down from higher levels of care. Respite occurs in a supportive environment, away from everyday stressors that may impact an individual's road to recovery and wellness. Yamhill County currently has 2 housing sites for adults and 1 housing site for youth that need crisis respite services.

Mobile Crisis Team

Yamhill County has a team of responders who can support people experiencing a behavioral health related crisis. Community Outreach Services (COS) are available to all residents of Yamhill County 24 hours a day, every day of the year. COS can provide crisis services, safety planning, evaluation for higher levels of care, stabilization referrals, resources, and supports to youth and adults.

COS can be reached through the National Suicide & Crisis Lifeline (dial or text 988), the Yamhill County Crisis Line (1-844-842-8200) or non-emergency dispatch. If you or someone you know is experiencing a behavioral health crisis, you can call and request COS. COS takes information from callers and can provide an in-person, face-to-face response, or over-the-phone assistance, if preferred to the person experiencing the crisis.

ADULT SERVICES

Adult Outpatient Services

The Adult Outpatient Services Team works with adults needing support and treatment for mental health concerns and challenges.

Services are based on evidence-based practices to maximize recovery and wellness, and include:

- Individual counseling and therapy
- Group therapy

We specialize in multiple treatment options, such as:

- Psychiatric Medication Support
- Solution Focused Brief Therapy
- Cognitive Behavioral Therapy for Anxiety and/or Depression
- Dialectical Behavioral Therapy
- Seeking Safety Group
- Acceptance & Commitment Therapy
- Making Changes for Good Groups
- Dual Disorder Treatment Groups
- Eye Movement Desensitization and Reprocessing (EMDR)
- Cognitive Behavioral Therapy (CBT) Essentials for Vulnerable Adults
- Mindfulness Based Stress Reduction

Intensive Community-Based Services

Assertive Community Treatment

The Assertive Community Treatment (ACT) program is an evidence-based service model for providing community-based treatment to persons with severe and persistent mental illnesses (SPMI). The ACT model has been shown to decrease the amount of time persons with SPMI spend in hospitals as well as increase successful community reintegration.

The range of treatment and services is comprehensive and flexible. The majority of interventions take place out of the office and within the community.

Early Assessment & Support Alliance

The Early Assessment and Support Alliance (EASA) provides support to individuals, age 12 to 27, who are experiencing symptoms of psychosis for the first time. EASA is a two-year outreach and treatment program that offers the following services:

- Outreach and engagement
- Individualized assessment, diagnosis, and treatment planning
- Education and support for individuals and primary support systems
- Crisis and relapse planning
- Assistance with knowing rights and available benefits
- Goal setting and planning
- Mentoring and opportunities to meet others
- Independent living skill development
- Access to community resources
- Support for work and school settings
- Group and individual counseling
- Medication support

EASA works closely with family members and others who are supportive of the individual to help them succeed.

Supported Education & Employment

The Supported Education and Employment program offers evidenced-based supported employment and education services for individuals experiencing challenges with obtaining or maintaining a job or education due to their mental health condition.

Employment services:

- Career planning
- Vocational counseling
- Work incentives/benefits counseling
- Resume writing
- Interview skills training
- Job search assistance
- Job placement
- On-going supports to help keep a job

Education services:

- Identifying education goals
- Pre-enrollment planning
- Education assessments
- Program selection
- Applications

- Financial Planning, grants, scholarships
- Enrollment, books, resource needs
- On-going follow-along supports

Supportive Housing

Yamhill County HHS has a variety of housing supports for clients, including crisis, respite, transitional, and permanent supported. There are a total of 164 units. In addition, a residential team from Yamhill County Mental Health works in coordination with individuals' case managers to provide a vast array of services to assist residents in maintaining community living. Services include medication monitoring, conflict resolutions skills, emotional regulation skills, money management, symptom management, cooking and grocery shopping.

Vulnerable & Older Adult Services

Behavior Support Services

The Behavior Support Services (BSS) program is designed to help people on Medicaid attain and maintain an optimal level of emotional and social functioning. BSS focuses on developing supports within the person's environment and improving interactions with caregivers to address:

- Challenging behaviors
- Cognitive processing
- Communication skills
- Self-help activities
- Impulse control
- Adaptive skills

The goal of BSS is to reduce the frustration, injuries, stress, unsuccessful placements, and

concerns that can be present when individuals who have persistent and challenging behaviors are not provided the support that they and their caregivers need.

Enhanced Care Facility

The Enhanced Care Facility (ECF) is an Aging and People with Disabilities (APD) licensed community based residential program. Enhanced Care is designed to provide 24-hour supervision and support to eligible individuals who experience challenging behaviors and psychiatric symptoms.

Enhanced Care Outreach Services

Enhanced Care Outreach Services (ECOS) is a program that provides individualized wrap-around rehabilitative behavioral health services to individuals residing in Aging and People with Disabilities (APD) licensed community settings. Services generally include assessment, service planning, individual therapy, consultation, individual skills training, medication management, facilitation of quarterly treatment team meetings, 24-hour crisis coverage, and provider staff trainings. People served in ECOS must meet Enhanced Care Facility (ECF) eligibility.

Older Adult Behavioral Health

The Older Adult Behavioral Health Initiative (OABHI) was launched in 2015 to:

- Increase availability and access to services and supports for older adults and adults with disabilities
- Promote multi-system collaboration and coordination between multiple agencies
- Provide community-wide education to professionals to enhance the capacity of Oregon communities to support the needs of older adults and people with disabilities

In collaboration with local partners, Older Adult Behavioral Health Specialists (OABHS) assess community needs, identifies gaps in services, eliminates barriers, promote best practices and evidence-based approaches, provide information and training, and maintain local resources for older adults.

Older Adult Peer Outreach for Depression & Substance Use

Older Adult Peer Outreach for Depression and Substance Use (OPODS) is available to Yamhill County residents aged 55 or older who are experiencing mild to moderate depression,

loneliness, substance use, and/or age-related concerns. The goal of this program is to reduce substance use and depression in older adults in Yamhill County.

Outreach, Assistive Services, and Integrated Supports

Outreach, Assistive Services, and Integrated Supports (OASIS) serves individuals with mental health conditions who have difficulty accessing traditional outpatient behavioral health services due to chronic medical/physical issues. OASIS provides assessment & service planning, individual therapy, consultation, individual skills training, peer support services, case management, and care coordination to older adults, adults with complex needs, and individuals with disabilities who require a higher level of care coordination with other service agencies.

Most services are provided on an outreach basis – so individuals can receive mental health support in their home or other community settings. Specific services may also be provided virtually.

PASRR Evaluations

Pre-Admission Screening & Resident Review (PASRR) is a federally required component of the state Medicaid program intended to ensure that nursing facility residents with serious mental illness are identified, appropriately placed, and provided with the services they need.

Our program provides PASRR level II evaluations & reviews to verify diagnosis, determine the most appropriate service setting, and facilitate specialized services as needed. The PASRR evaluator may also provide referrals and linkage to other support services.

PASRR services are typically requested by hospitals or the nursing facility where the individual resides.

Residential Treatment Facility

The Residential Treatment Facility (RTF) is a licensed community-based residential program. This medically focused RTF provides 24-hour supervision and support to individuals experiencing mental illness and medical conditions. The program is considered transitional in focus with the goal of supporting individuals in moving to more independent settings as they are ready.

Mental Health Court Services

Jail Diversion services are available to adults that, due to a serious and persistent mental illness, are subject to arrest or have been arrested for a non-violent felony or misdemeanor. The purpose is to divert individuals from incarceration by linking them with appropriate mental health in the community.

The Jail Diversion team attends local Community Courts and Mental Health Court in hopes of identifying and assisting people struggling with legal charges due to their mental illness.

Case Management and Peer Support

Sometimes individuals with severe mental illness struggle with navigating the complex legal system. Jail Diversion Case Management or Peer Support can come alongside and help with identifying next steps, creating a plan, communicating with legal teams, the courts or DA's office, along with locating resources or needed supports such as housing, food stamps, treatment services, medications, and more. People are usually referred to case management or forensic peer support by their YCHHS treatment providers, the courts, or COS staff. These services are voluntary.

Problem Gambling Treatment

Yamhill County provides a full-service outpatient Problem Gambling Treatment program. State certified gambling treatment counselors can provide a full clinical assessment and collaboratively develop an individualized treatment plan. Group and individual treatment

services are available in a safe and confidential environment. In addition, we offer treatment and support for family members, even if the problem gambler is not involved in treatment. We offer co-occurring disorder treatment as well as community outreach and after-care problem gambling services.

There is no out-of-pocket cost to clients or their families as treatment is funded by the Oregon Health Authority. We work very closely with Oregon's only residential gambling treatment inpatient program located in Salem. We can easily facilitate a referral to the inpatient program if a higher level of care is needed.

Intensive In-Home Behavioral Health Treatment

Intensive In-Home Behavioral Health Treatment (IIBHT) is a team-based treatment model that offers a combination of services and supports delivered in a community or home-based setting. Services and supports include:

- Case management
- Psychiatric services
- Skills training
- Individual and family therapy
- 24/7 crisis support
- Peer support

IIBHT provides intensive and individualized care to youth who have complex mental health and/or behavioral health needs. The goal of this model is to support the youth/family in a natural environment, such as the home, and successfully maintain the youth in the home or reintegrate back into the home.

Parent-Child Interaction Therapy

Parent-Child Interaction Therapy (PCIT) is an intensive therapy aimed at improving behavior by promoting positive parent-child relationships. It uses in-the-moment, experience-based methods, and coaching. PCIT helps parents more effectively manage their child's behaviors, helps children be more cooperative, and improves the quality of parent-child relationships. This therapy is also effective in reducing the severity of trauma symptoms and helps children learn to regulate their emotions and behavior better.

During a PCIT coaching session, a therapist will watch you and your child interact through a one-mirror and/or live video feed. You will wear an earbud device allowing the therapist to provide in-the-moment coaching on skills that help you manage your child's behavior.

Wraparound Care Coordination

When efforts with individual and family counseling haven't been enough to safely address more complex and severe problems, parents may request a more intensive care coordination called Wraparound Care Coordination.

Wraparound Care Coordination is a planning process that follows a series of steps to support

youth and their families to accomplish their goals. A team is identified by the family for support and typically includes a Care Coordinator, individuals that the youth is close to (i.e., family members, friends, neighbors, church members, coaches etc.), and may include school staff, therapists, DHS case workers, P.O.s, or others. The team will develop a Care Coordination Plan and a Safety Crisis Plan. They will also look at additional supports and professional services as necessary.

These intensive services are available when a youth is involved in multiple systems, in addition to mental health services, such as Special Ed, Juvenile Probation, Child Welfare (ODHS), or Intellectual/Developmental Disabilities. Services provided could include active case management and skills training in the home or school. When a child's high-risk behavior cannot be stabilized, brief psychiatric day treatment, brief psychiatric residential or acute hospitalization may be considered. Each service is carefully considered by the team and offered only with the permission of the parents and when clinically necessary.

School Services

Yamhill County Family and Youth partners with local school districts to provide mental health services for all students in each district that we serve, regardless of insurance status. In addition, we also offer limited drug/alcohol prevention and treatment when requested by youth, parent, or schools. Some schools also offer medical care, behavioral health services, and preventive health services through School-Based Health Centers (SBHCs) in Willamina and McMinnville.

Services include:

- School-based counseling
- School-based parent education and support
- Alcohol and drug screening
- Threat assessments and crisis screenings
- Behavior support and case management
- Integrated care coordination between school staff, primary care providers, county- and community-based services providers, and therapists
- Social and behavioral skill-building groups
- Crisis debriefs for students and staff

Alcohol and Drug Treatment

Adult Services

Yamhill County Substance Use Services offers a wide array of treatment options and programs. Our highly trained and experienced Certified Drug and Alcohol Counselors specialize in working with each client to develop a comprehensive, individualized plan of recovery.

Culturally skilled services are available for Spanish Speaking individuals. All individuals are offered a no-cost screening/orientation appointment to obtain information regarding programs we offer that may best meet their needs.

A walk-in option is available for those seeking services for alcohol and drug use and abuse issues. We are available Monday through Friday from 7:30am-5:30pm at the Adult Behavioral Health building.

Alcohol and drug counseling and groups include:

- Individual counseling and therapy groups
- Groups and counselors for individuals with co-occurring disorders

Adult Recovery Court Program

With the support of the court system, the Yamhill County Specialty Drug Court Program assists clients in the successful accomplishment of Drug Court requirements. Participants can receive both mental health and substance use disorder services, if needed, and have access to

medication assisted treatment (MAT). All participants choosing the program will work with the team to develop plans that are specific and unique to their particular needs and issues. The treatment courts work to help clients prioritize and address these issues in a timely, realistic, and effective manner. It is a highly specialized program lasting 12 to 18 months and serves (treats) long time criminal offenders. Participants are referred through the legal system.

DUII Services

Yamhill County Adult Behavioral Health offers a state-licensed program for people who have been arrested for driving under the influence of intoxicants (DUII). Services include both education and treatment for DUII. Participants will be expected to participate in random, monitored (observed) urinalyses (UA's) one time per week. Upon successful completion of the program, participants will satisfy treatment requirements for the Oregon Department of Motor Vehicles (DMV). Yamhill County accepts Oregon Health Plan (OHP) and most private insurances for DUII services.

Intensive Outpatient Treatment

The Intensive Outpatient Treatment (IOP) group focuses on a higher level of outreach and engagement with clients who come into services. The providers offer a unique set of skills and styles to help clients who are struggling with abstinence. Specialty training and skills in this team include social work, dual diagnosis, criminal thinking, and community-based support knowledge. The IOP program has

the ability to provide contact five days a week and to offer access to more than one therapist for specialized support based on a client's individual needs. Individual sessions are available in addition to traditional group therapy. A client who may be appropriate for residential treatment services can be supported on an interim basis or until a residential bed becomes available.

Medication Assisted Treatment

Yamhill County Behavioral Health provides Medication Assisted Treatment (MAT) for people who are diagnosed with an opiate substance use disorder and/or alcohol use disorder. MAT involves the use of medications in combination with counseling and behavioral therapy. The medications we prescribe reduce the cravings, or withdrawal symptoms, that can be associated with use, depending on the medication, for alcohol or opiate drugs and can help some people sustain recovery and prevent overdose. We offer both oral and longer-acting injectable medications.

Transitional Treatment Recovery Services

The goal of the Transitional Treatment Recovery Services (TTRS) program is to provide drug and

alcohol-free housing along with intensive substance use treatment, and other supportive and family stabilization services in a structured, supervised environment. This program also promotes the return of children to their parent’s care sooner or eliminate the need to place children in foster care by providing treatment, support, and guidance. There are currently six homes offering TTRS.

Individuals enrolled in TTRS have access to the following services:

- Substance use treatment including group and individual counseling, family counseling, cognitive behavioral therapy (CBT), and drug court services.
- Mental health treatment including group and individual counseling, crisis services, mental health court services, and medication services.
- Social and life skills training
- Access to peer mentor services
- Access to parenting classes and parenting coaches
- Access to public health nurses for support and resources during pregnancy and for newborns

- Supported employment and education services.

Youth Services

Yamhill County Family and Youth Services provides outpatient alcohol and other drug treatment for adolescents and their families. Services begin with an assessment to identify needs related to substance abuse issues and co-occurring mental and/or physical health issues. The clinician and individual will determine the most appropriate treatment based on the initial assessment. Treatment consists of a trained and certified clinician assisting an individual toward an improved quality of life.

Services offered include:

- Adolescent outpatient treatment
- Juvenile DUII diversion and conviction program
- Program for clients with co-occurring disorders
- Youth alcohol and drug counseling
- Youth alcohol and drug group treatment and family support groups
- Minor in possession (MIP)/driving under the influence of intoxicants (DUII) diversion classes
- Referrals to residential treatment

Juvenile Drug Court

Yamhill County Family and Youth partners with Juvenile Justice, the Courts, and other community partners to provide an evidence-based intervention for youth who are involved in drug/alcohol use and on probation. Drug Court provides an alternative way to address

the underlying reasons for drug use and criminal behavior to effectively change behavior, reducing recidivism, and building positive prosocial connections for the youth. The youth, their family, the youth’s therapist, attorney, Judge, probation officer, and peer supports meet weekly to support the youth in their recovery.

Youth DUII and MIP Services

Youth that have been cited with Driving While Under the Influence of Intoxicants (DUII) or with a Minor in Possession of Alcohol (MIP) meet with a Certified Alcohol & Drug Counselor (CADC) to determine their level of care. The levels of care that we provide range from early intervention and education to intensive outpatient care. The amount and frequency of services recommended increases with the higher levels of care. If a higher level of care is needed in order to maintain safety of the client and others, our counselors discuss their recommendations with the client and complete referrals to the appropriate programs.

We also coordinate with the referring juvenile probation officer and other involved agencies in order to help youth successfully complete their requirements and meet their treatment goals.

Developmental Disabilities Services

The Yamhill County Developmental Disabilities (YCDD) program offers services for children and adults with Intellectual Disabilities and other qualifying Developmental Disabilities (I/DD) residing in Yamhill County.

Additional services include:

- Licensing for adult foster care
- Certification for youth foster care
- Support with becoming a Personal Support Worker (PSW)



Applying for Services and Eligibility

Those that are interested in receiving services must apply to see if they are eligible. The application and required documentation can be found on our website or in person at our office. Staff are available by appointment to help answer questions or with filling out the application. Call or email us to schedule an appointment.

Our Eligibility Specialist will contact applicants to gather more information about their condition and receive written consent to request records from medical providers, schools, and other sources. When more information is needed, an evaluation with a

qualified professional may be requested. We are allowed up to 90 days to complete this process.

Support Services and Case Management

YCDD works with individuals and their families or support persons who have intellectual and or developmental disabilities. The team of staff support people with individual needs planning, case management, and facilitating the delivery of needed services. The case manager supports the individual in achieving their goals through a client centered and strength-based lens.

Abuse Investigations and Protective Services

If you think someone is in danger of being hurt, call 911 immediately!

If you suspect abuse or neglect of an adult with an intellectual or developmental disability call YCDD at 503-434-7460 or the Safe Line at 503-434-SAFE to make a confidential report.

When a report is made the assigned investigator will gather information from the reporter to assess the adult's immediate health and safety, coordinate a plan for needed protective services, and determine if the report meets one of Oregon Revised Statute (ORS 430.735) definitions of abuse. If the report meets one of the definitions, an investigation will begin. The primary purpose of protective services and an abuse investigation is to prevent further abuse.

PREVENTION PROGRAMS

Alcohol and Drug Prevention

The Alcohol and Other Drug Prevention Education Program (ADPEP) provides free education, resources, and technical assistance to community members and organizations in Yamhill County interested in alcohol and drug prevention. Presentations are available for schools or other organizations upon request.

Community Prevention & Wellness

The Community Prevention and Wellness (CPW) Coordinator works with the CPW Committee to connect schools and other local organizations to evidence-based prevention programs that improve health and wellness.



The CPW Coordinator also acts as the Hub Coordinator for Oregon Health & Science University Moore Institute's Nutrition Oregon Campaign. The Yamhill Hub currently has working groups focused on health and nutrition literacy, and food access for those with limited transportation. The goal of the campaign is to create a culture that values nutrition so that

100% of the population has access to nutritious and culturally relevant food by 2029.

Friends Fight Fentanyl is a collaborative effort by the public health departments of Yamhill, Marion, and Polk Counties to raise awareness about illegal fentanyl, the harm it causes, and the steps that local teens can take to protect their friends and themselves from this devastating drug.

Tobacco Prevention & Education

The Tobacco Prevention and Education Program (TPEP) offers various smoking and vaping cessation programs for youth and adults. These programs vary from a one-time session to multiple sessions, depending upon the individual or organization.

Programs offered include:

- CATCH My Breath (Coordinated Approach to Child Health): an evidence-based youth vaping prevention program.
- Intervention for Nicotine Dependence: Education, Prevention, Tobacco, and Health (INDEPTH): an alternative to suspension or citation that helps schools and communities address teen vaping.
- Not On Tobacco (N-O-T): a teen smoking and vaping cessation program.
- Freedom From Smoking: an online or in-person smoking cessation program.

These programs can be requested by schools or community groups. Printed resources and tobacco free signs and stickers are also available upon request.

The Oregon Tobacco Quit Line

Trying to quit smoking? The Quit Line is a telephone and web-based counseling service to help Oregonians quit using tobacco and nicotine products.



In addition to our prevention and education programs, the TPEP Coordinator is also responsible for handling violations of the Smokefree Workplace Law, or the Oregon Indoor Clean Air Act (ICAA). This law prohibits smoking and vaping within 10 feet of entrances, exits, windows that open, and ventilation intakes of workplaces and public places. Business owners are responsible for enforcing this law. COMMUNITY NURSE PROGRAMS

Family Connects

The Family Connects Oregon program supports parents by linking nurses, community resources, and families. Our mission is to connect parents with resources that nurture the whole family and support the child. It's about planting seeds for the future. Together, we're growing healthy babies!

Babies First!

Babies First! is a community nursing program for families with babies and children up to age 5. The goal of Babies First! is to help families make sure that their babies are healthy as they grow and learn. Public health nurses make home visits to help families learn to care for their child, provide developmental screens, and connect to community resources.

CaCoon

CaCoon is a community nursing program that helps families with children with special needs. A CaCoon public health nurse can help with referrals to other services, answer questions about a child's health needs, and help with coordinating health care.

Nurse Family Partnership

The Nurse Family Partnership program is for first time mothers that enroll before they are 28 weeks along in their pregnancy. The nurse will make home visits to offer advice, support, and resources throughout the pregnancy and until the baby is 2 years old.

FamilyCore

FamilyCore is a community services network that connects parents with a broad support system to meet challenges head-on and to nurture strong families with children ages 0–5.

PUBLIC HEALTH CLINIC

Services offered in the Yamhill County Public Health clinic include:

- Adult and child immunizations including the annual flu vaccine
- Sexually transmitted infection (STI) testing and treatment

All services are completely confidential. Insurance is accepted but no patient will be refused services based on their ability to pay. Payment plans and sliding scales based on income are also available.

OTHER PUBLIC HEALTH SERVICES

Birth and Death Certificates

Yamhill County Vital Records maintains Birth and Death Records for 6 months from the date of birth or death for the purpose of providing certified copies. Copies can be ordered and obtained at the Public Health reception desk. There is a \$25 fee per copy.

If certified copies are needed after 6 months from the date of birth or death, please contact Oregon Health Authority Center for Health Statistics at 971-673-1190.

Communicable Disease Program

The Communicable Disease (CD) Team is responsible for the investigation and control of communicable diseases and reporting them to

the Oregon Health Authority (OHA). The CD Team monitors and investigates communicable diseases such as Hepatitis, E. Coli, Salmonella, and Sexually Transmitted Infections (STIs). Additionally, the CD Team provides case management for active cases of Tuberculosis (TB), which is available at no cost to the client. The CD Team also performs outbreak investigations to stop the spread of the disease to the community. Staff can provide information about the disease and consult with local healthcare facilities, schools, daycares, and providers during outbreaks.

Animal Bites

The CD Team acts as a point of contact for animal bites. Anyone with knowledge of a bite should report its occurrence immediately. Once the CD Team receives an animal bite report from healthcare providers, Urgent Care Clinics, and Emergency Departments, they then perform an investigation regarding the animal bite to see if vaccination, treatment, and/or animal testing for rabies is needed. The testing for rabies is performed at Oregon State University Veterinary Diagnostic Laboratory.

Emergency Preparedness

Yamhill County Public Health works with individuals, families, and local organizations and agencies to prepare for public health emergencies. These emergencies include health threats that pose a high probability of a large number of deaths, serious or long-term disabilities, or widespread exposure to an infectious or toxic agent that poses significant harm.

Some examples of public health emergencies include:

- Bioterrorism
- A novel (new) or previously eradicated infectious agent or biological toxin that may be highly contagious
- An epidemic of a communicable disease
- A natural disaster (earthquake, tornado, wildfire, flood, etc.)
- A chemical/nuclear attack or accidental chemical/nuclear release

The Public Health Emergency Preparedness Coordinator works closely with Yamhill County Emergency Management to develop emergency response plans, provide trainings for organizations and the public, and assist the community during emergencies.

Medical Reserve Corp

The Medical Reserve Corp (MRC) is a community-based volunteer group based in Yamhill County, that are called upon to assist and respond to public health disasters and emergencies. The group consists of local licensed healthcare professionals, public health professionals, students actively studying in the healthcare field, and those retired whose license is in good standing.



MRC volunteers:

- Train with local emergency response partners

- Assist local hospitals and Yamhill County Public Health with surge personnel needs
- Participate in community preparedness activities and trainings such as exercises for mass sheltering and vaccination clinics
- Assist Yamhill County Public Health with community health events

Environmental Health Program

The Environmental Health program licenses and inspects multiple types of facilities, such as:

- Permanent and temporary food service establishments and mobile food units
- Public swimming pools and spas
- Tourist facilities
- Schools with USDA food programs
- School food service facilities
- Certified Daycare operators



Additional services offered by the Environmental Health program:

- Food Service worker training
- Performing Water System Surveys of small public water systems and assisting operators of those systems with monitoring and compliance

Restaurant Inspections & Licensing

All restaurants in Yamhill County are required to have a license including permanent restaurants, temporary, intermittent, or seasonal restaurants, and mobile units. New restaurants will need to provide a license application, a plan review application, and a license fee, and receive an inspection. Each license expires on December 31 each year and must be renewed. Visit our website for more information on fees and how to submit an application.



All licensed restaurants and mobile units are subject to unannounced inspections once or twice per year. These inspections focus on items most likely to cause illness or injury to patrons of these facilities, but also include items such as general cleanliness and maintenance. Full restaurant inspection results can be found on our website.
