The Yamhill County Board of Commissioners hereby
ordain that Ordinance #179 be and hereby is repealed and
that the Building, Mechanical and Plumbing Ordinance #173, 1978,
be and hereby is amended as follows:

Section 1. Paragraphs 3 and 4 of Section IX is
hereby repealed and is no longer a part of said
Ordinance. The following are the new Paragraphs 3
and 4 of Section IX of said Ordinance which shall
replace the prior Paragraphs 3 and 4 in their
entirety:

3. The schedule of fees to be charged for
the issuance of a permit and for plan check-
ing under this Ordinance is as provided in
Section 303 of the 1976 Code, except that
the Yamhill County Board of Commissioners
may from time to time, by Order of the Board,

amend, change, increase, or decrease said fees and charges.

4. The schedule of fees to be charged for the issuance of a Plumbing Permit under this Ordinance shall be established by the Yamhill County Board of Commissioners by Order of the Board, which schedules may, from time to time, be amended, changed, increased or decreased by Order of the Board.

Section 2. This Amendment to the Yamhill County Building, Mechanical and Plumbing Ordinance #173, 1978, being necessary for the health, safety and welfare of the people of Yamhill County and the Board of Commissioners having declared an emergency to exist, this Amendment shall be effective upon the approval hereof.

NOW, THEREFORE, after public hearing and reading on March 7, 1979, before the Yamhill County Board of Commissioners, in regular session, an emergency having been declared, and upon motion duly made and regularly passed, this Amendment to the Yamhill County Building, Mechanical and Plumbing Ordinance


