An Ordinance Repealing Ordinance No. 216. )  
ORDINANCE NO. 262 )

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (the Board), on the 15<sup>th</sup> day of April, 1981 sat in regular session for the transaction of County business, Commissioners COLIN ARMSTRONG, TED LOPUSZYNSKI and ROBIN J. HAMBLET being present.

WHEREAS, the Board, on June 13, 1979 enacted Ordinance No. 216 amending Yamhill County Zoning Ordinance No. 83, 1976, changing the official Zoning Map Designation for Tax Lot 5405-1200 from EF-40 (Exclusive Farm/40 acre minimum) to Light Industrial; and

WHEREAS, said Ordinance was appealed to the Land Conservation and Development Commission, which Commission reversed the decision of Yamhill County on September 5, 1980; and

WHEREAS, LCDC action was appealed to the Court of Appeals for the State of Oregon, which Court affirmed the action of LCDC on December 1, 1980; and

WHEREAS, the Supreme Court of the State of Oregon was petitioned for review of the Court of Appeals decision, which Petition for Review was denied on March 17, 1981; NOW, THEREFORE

THE YAMHILL COUNTY BOARD OF COMMISSIONERS HEREBY ORDAINS AS FOLLOWS:

That Ordinance 216 be and hereby is repealed and that the Zoning Map Designation for Tax Lot 5405-1200 on the official Zoning Map is hereby returned to the designation of EF-40.
