THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (the Board) sat for the transaction of county business on February 1, 1989 in regular session, Commissioners Ted Lopuszynski, David E. Bishop and Dennis L. Goecks being present.

WHEREAS, on April 27, 1988, in Ordinance 464 the Board approved a zone map amendment relating to Yamhill County Tax Lot 3216AB-1800; and

WHEREAS, in the text of Ordinance 464 the subject property was erroneously referred to as Tax Lot 3218AB-1800, rather than properly referred to as Tax Lot 3216AB-1800; and

WHEREAS, the map attached as Exhibit "B" to Ordinance 464 properly referred to the subject property as Tax Lot 3216AB-1800; and

WHEREAS, this ordinance is necessary to correct the typographical error in Ordinance 464 referred to above; Now, Therefore,

THE YAMHILL COUNTY BOARD OF COMMISSIONERS ORDAINS as follows:

Section 1. All references to Tax Lot 3218AB-1800 in Ordinance 464 are hereby corrected to properly identify the property as Tax Lot 3216AB-1800.

Section 2. Except as specifically modified by Section 1 herein, all terms and provisions of Ordinance 464 shall remain in full force and effect.

Section 3. This ordinance being necessary for the health, safety and welfare of the citizens of Yamhill County, and an emergency having been declared to exist, shall become effective upon passage hereof.
