ORDINANCE NO. 422

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (the Board) on the 4th day of December, 1985, sat for the transaction of County business in regular session, Commissioners Ted Lopuszynski, Donald D. Porter and David E. Bishop being present.

WHEREAS, the Yamhill County Dog Control Advisory Board and the Yamhill County Sheriff have requested an increase in certain license fees in order to provide adequate licensing revenue for the dog control program; and

WHEREAS, the Board has determined it to be in the best interests of the citizens of Yamhill County to ensure adequate funding for the dog control program: NOW THEREFORE

IT IS HEREBY ORDAINED BY THE BOARD as follows:

Section 1. Section 4.2 of the Yamhill County Dog Control Ordinance is hereby amended as follows:

- (i) Section 4.2(a) is amended by deleting "\$6.00" and inserting "\$7.00".
- (ii) Section 4.2(b) is amended by deleting "\$3.00" and inserting "\$4.00".
- (iii) Section 4.2(e) is amended by deleting "12.00" and inserting "\$13.00".

Section 2. This ordinance being necessary for the health, safety and welfare of the citizens of Yamhill County and an emergency having been declared shall be effective on the first day of January, 1986.

NOW THEREFORE, after public hearing and reading on the 20th day of November, 1985, and the 4th day of December, 1985, before the Yamhill County Board of Commissioners, and an emergency having been declared to exist, upon motion duly made and regularly passed, this ordinance was adopted on December 4, 1985.
