THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (the Board) on the 26th day of November, 1986, sat for the transaction of county business in special session, Commissioners Donald D. Porter, David E. Bishop and Ted Lopuszynski being present.

WHEREAS, on October 15, 1986, the Board enacted Ordinance 435, amending certain provisions of the Yamhill County Zoning Ordinance, No. 310, as amended; and

WHEREAS, ORS 197.610(1) provides that "a proposal to amend a local government acknowledged comprehensive plan or land use regulation or to adopt a new land use regulation shall be forwarded to the director (of the Department of Land Conservation and Development) at least 45 days before the final hearing on adoption"; and

WHEREAS, the Department of Land Conservation and Development has objected to the enactment of Ordinance 435 upon the ground, among others, that the county failed to provide notice required by ORS 197.610 as set forth above; and

WHEREAS, the Board finds that no notice was given as required by ORS 197.610 and that Ordinance 435 should be repealed and should have no legal effect; NOW THEREFORE,

IT IS HEREBY ORDAINED BY THE YAMHILL COUNTY BOARD OF COMMISSIONERS AS FOLLOWS:

Section 1. Ordinance 435 is hereby repealed in its entirety.

Section 2. The Yamhill County Zoning Ordinance, No. 310, as amended, shall continue in full force and effect as it existed immediately prior to the enactment of Ordinance 435.

Section 3. This action being necessary for the health, safety and welfare of the citizens of Yamhill County, and an emergency having been declared to exist, shall be effective upon passage hereof.
