

AMENDMENT #1 TO THE AGREEMENT FOR YAMHILL COUNTY FOOD SERVICES

This Amendment is made and entered into by and between Yamhill County (“Client”), and Summit Food Service, LLC (“Company”) (collectively “the Parties”).

WHEREAS, the Parties have entered into a certain Agreement for Yamhill County Food Services (the “Agreement”), effective June 26, 2023, memorialized in Yamhill County records as Board Order 23-214;

WHEREAS, the Parties have agreed to adjust pricing for the Agreement ; and

WHEREAS, the Parties now desire to amend said Agreement upon the terms and conditions stated herein.

NOW, THEREFORE, the Parties, intending to be legally bound hereby, mutually agree as follows:

1. **Payment Arrangement.** Per section 6 of the Agreement, Exhibit C, Section A.i. of the Agreement shall be amended to reflect that Company shall charge per the following scale:



- 2. **Future Pricing.** Section 6. of the Agreement shall be amended to the following language:
Pricing adjustments shall be made on an annual basis and shall be agreed upon by the parties at a rate no less than the greater of: five percent (5%), the most recently released U.S. Department of Labor Consumer Price Index, All Urban Consumers, National Average Unadjusted, Food Away From Home, or the changes in the Market Basket of Products. Up to ninety (90) days prior to the anniversary of the Commencement Date, Company shall provide Client notification of the adjustment. On the anniversary date, Company proposed adjustments shall go into effect, unless the Parties have entered into a written agreement with an alternative cost adjustment.

This Amendment is effective as of July 1, 2025. All other terms and conditions of the original Agreement (as modified from time to time) shall remain in full force and effect unless otherwise amended as provided in the Agreement.


