THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (the Board), sat for the transaction of county business in special session on Wednesday, June 24, 1992, Commissioners Ted Lopuszynski, Debi Owens, and Dennis L. Goecks being present.

WHEREAS, Yamhill County has been a member of the Mid-Willamette Valley Council of Governments (MWVCOG); and

WHEREAS, the member governments of MWVCOG desire to revise and reform the Charter and Agreement by which the MWVCOG is created; and

WHEREAS, ORS 190.085 requires that prior to the effective date of an intergovernmental agreement creating an intergovernmental entity, each of the parties to the agreement shall enact an ordinance ratifying the creation of the intergovernmental entity; NOW THEREFORE,

THE YAMHILL COUNTY BOARD OF COMMISSIONERS ORDAINS AS FOLLOWS:

Section 1. That it is the intent of the Board of Commissioners of Yamhill County to create, along with the other parties to the agreement, an intergovernmental entity known as the Mid-Willamette Valley Council of Governments.

Section 2. That the effective date, specification of public purposes for which MWVCOG is created, and the powers, duties, and functions of the MWVCOG are as stated in the agreement attached hereto as Exhibit "A" and by this reference incorporated herein.

Section 3. That the agreement is hereby ratified and the chairman and clerk are hereby authorized and directed to sign the same on behalf of Yamhill County.


Section 4. This ordinance being necessary for the health, safety and welfare of the citizens of Yamhill County and an emergency being declared to exist, is effective upon passage.
