

**AMENDMENT No. 1 TO YAMHILL COUNTY AND NORTHWEST CHRISTIAN
CHURCH
GRANT AGREEMENT**

THIS AMENDMENT is made and entered into this November 13, 2025, by and between YAMHILL COUNTY, a political subdivision of the State of Oregon, (“County”), and Northwest Christian Church (“Recipient”) (collectively, the “Parties”).

WHEREAS, The Parties executed “The Zone” Afterschool Program agreement on March 1, 2024 pursuant to Board Order No.24-65 for Recipient’s expansion of The Zone Afterschool Program in Yamhill County (the “Contract”); and

WHEREAS, The Parties now wish to amend the Contract as provided herein; and now, therefore

THE PARTIES hereby agree to amend the Contract as follows:

1. Section I.3 of the Contract is hereby amended to extend the term of the Contract to December 31, 2026.
2. This amendment is retroactive to March 1, 2025.

Except as expressly amended above, all other terms and conditions of the original Contract are still in full force and effect. The Recipient certifies that the representations, warranties, and certifications contained in the original Contract are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
