

AMENDMENT No. 1

**TO YAMHILL COUNTY AGREEMENT FOR CORRECTIONAL
HEALTHCARE SERVICES CONTRACT BETWEEN YAMHILL COUNTY
SHERIFF'S OFFICE AND DEPARTMENT OF COMMUNITY JUSTICE
AND MEDTRUST, LLC.**

Contract No. SO25018GS (B.O. 24-363)

This Amendment No. 1 ("Amendment") is made and entered into on this 04th December 2025, by and between YAMHILL COUNTY a political subdivision of the State of Oregon, acting by and through its Sheriff's Office and its Department of Community Justice, ("County") and MedTrust, LLC doing business as MedHealth, (collectively the foregoing parties will be referred to as "the parties").

WHEREAS, The Parties executed a services contract on January 1, 2025 pursuant to Board Order No. 24-363 medical services to Individuals in Custody (IICs) housed in either the Yamhill County Correctional Facility or the Yamhill County Youth Services Center (collectively referred to herein as the "Facility"); (the "Contract"); and

WHEREAS, The Parties now wish to amend the Contract to modify contracted medical staffing set forth in the Agreement to better service Adults in Custody (AIC); and

WHEREAS, these staffing changes will have no impact on the compensation set forth in the Agreement; and

WHEREAS, the Parties desire to eliminate the staffing positions of Medical Records/AA and Certified Medication Aide previously included under the Contract and to add a new MAT (Medication Assisted Treatment) Coordinator position; and

WHEREAS, the MAT Coordinator shall be a full-time nurse position with a primary focus on overseeing the MAT program in the Yamhill County Correctional Facility.

NOW THEREFORE, in consideration of the mutual benefits and covenants contained herein, the parties agree to amend the Agreement as follows:

1. Exhibit A to the Contract is hereby deleted in its entirety and replaced with Exhibit A to this amendment, attached hereto and incorporated herein by this reference.
2. The position description for the MAT (Medication Assisted Treatment) Coordinator, set forth in Exhibit B to this amendment attached hereto and incorporated herein by this reference, shall establish the duties and responsibilities of the MAT Coordinator position.

Except as expressly amended above, all other terms and conditions of the original contract are still in full force and effect. The Contractor certifies that the representations, warranties, and certifications contained in the original contract are true and correct as of the effective date of this

Amendment and with the same effect as though made at the time of this Amendment.

IN WITNESS WHEREOF, the parties have executed this Amendment in their official capacities and possess proper legal authority to make this Agreement binding.
