Subject: Request for Approval to Apply for Behavioral Health Deflection (BHD) Grant – Phase II

On August 28, 2025, Yamhill County submitted Phase I of the Criminal Justice Commission's (CJC) Behavioral Health Deflection (BHD) Grant application and was awarded \$199,997 to support the initial implementation of the 2025–2027 Yamhill County Deflection Program. As outlined in our September 12, 2025, memo to the Board, the original program design focused solely on the Officer Intervention pathway and included a preliminary grant request of \$907,552. That memo also noted that the CJC grant process would follow a two-phase structure, with final funding based on projected deflection numbers across six nationally recognized treatment pathways.

In Phase II, the County was required to estimate the number of individuals who could enter the program through these pathways. This analysis was completed and submitted on September 25, 2025, and led to the expansion of the program to include four additional deflection pathways: Community Response, First Responder Referral, Active Outreach, and Self-Referral.

Following review of this expanded model and staff recommendations, the CJC Committee met on October 21, 2025, and awarded Yamhill County an allocation of up to \$1,838,506 (inclusive of the Phase I award) to support continued development and implementation of the Deflection Program. These enhancements are designed to increase access to treatment and support services while reducing reliance on the criminal justice system.

We are now seeking Board approval to submit a joint grant application totaling \$1,838,506.00, as allocated by the CJC and outlined below, to support BHD-related programs operated by the Sheriff's Office, District Attorney's Office, and Health and Human Services. The Sheriff's Office will serve as the lead agency and grant coordinator for this collaborative effort. This application reflects a strong, countywide partnership that includes the County Court Judges, Yamhill Communications (PSAP), Health and Human Services, all local law enforcement agencies, the

Oregon State Police, and other community stakeholders—working together to strengthen deflection pathways and improve outcomes for individuals in crisis.
