

YAMHILL COUNTY AMBULANCE SERVICE AREA ADVISORY COMMITTEE (ASA)

- Creation:** This committee is established pursuant to Ordinance No. 946 and Yamhill County Code Chapter 5.05. This committee was originally created under Ordinance No. 723; however, Ordinance No. 723 was repealed by Ordinance 946, which reestablished and continued this committee. This committee shall exercise the duties and authority set forth in Chapter 5.05 of the Yamhill County Code.
- Membership:** 14 members, designated positions. 7 members shall constitute a quorum. The committee shall elect a chairperson.
- Terms:** 1-3 years staggered; subsequent appointments shall be for 2-year terms. Members may resign or be removed by the Board; otherwise, members shall serve until their successors are appointed and qualified. Vacancies will be filled for the balance of the unexpired term. Persons may be appointed to successive terms.
- Meetings:** The committee shall meet at such times as it deems necessary or as called by the Administrator or the Board of Commissioners.
