Dear Property Owner:

In accordance with ORS 305.286, whenever any property value or claim for exemption or cancellation of a property tax assessment is appealed, if the dollar amount in dispute exceeds \$1 million, the assessor of the county in which the property is located may order the officer in charge of the assessment and tax roll to issue a potential refund credit.

Upon payment of the 2020-2021 taxes, the county treasurer shall withhold the amount of tax included in the potential refund credit and deposit the amount into a trust fund administered by the county treasurer.

This is notification that the Yamhill County Assessor has ordered a potential refund credit for the 2018-2019, 2019-2020 & 2020-2021 tax years in the amount of \$212,414.55 as itemized on the enclosed schedule.


